ELIGIBILITY CRITERIA:

1. Singapore Citizen or Permanent Resident of Singapore;
2. At least 21 years of age;
3. Singapore-based jazz musician;
4. Primary livelihood is that of a professional jazz musician for at least three (3) consecutive years*;
5. Impacted by crisis and presently experiencing loss of monthly personal income of at least 40% for at least three (3) consecutive months*; and
6. Not a full-time National Serviceman.

Eligibility for application does not guarantee the award of the grant

*In view of these unprecedented times due to COVID-19, JASS may, in its discretion, consider cases which fall outside eligibility criteria 4 and 5 for grant application period 1 Aug to 31 Aug 2021.

ASSESSMENT CONSIDERATIONS:

The Jazz Association (Singapore) ("JASS") will award a one-time grant of up to S\$1,800 to each successful applicant. The number and quantum of grants to be awarded will be subject to the availability of funds. In most cases, first-time applicants will be given priority. Applications may re-open or be extended depending on fund availability.

Grant support will be based on the assessment of the needs of the applicant, his/her household needs if relevant, as well as the applicant's contributions to the Singapore jazz scene.

The assessment panel ("Panel") will comprise JASS Board Directors who may, where necessary, seek advisory inputs on an ad-hoc basis from person(s) ("Advisor(s)") on aspects relating to the Singapore jazz scene and/or other areas such as financial aid practices. Such Advisor(s) will be bound by confidentiality obligations.

In order to help the Panel assess the application, we encourage applicants to kindly highlight your situation and needs, as well as your contributions to the local jazz scene in as much detail as possible. The information you provide will be treated with confidentiality. Following your application, we may also contact you for clarification or more information and may also arrange for a short interview with the Panel, if necessary.
